■ **George Hunsinger, PhD**, is founder of the National Religious Campaign Against Torture and Hazel Thompson McCord professor of Systematic Theology at Princeton Theological Seminary. He earned his Ph.D. from Yale University and is an ordained Presbyterian minister. Dr. Hunsinger is author of *Torture Is a Moral Issue: Christians, Jews, Muslims and People of Conscience Speak*.
